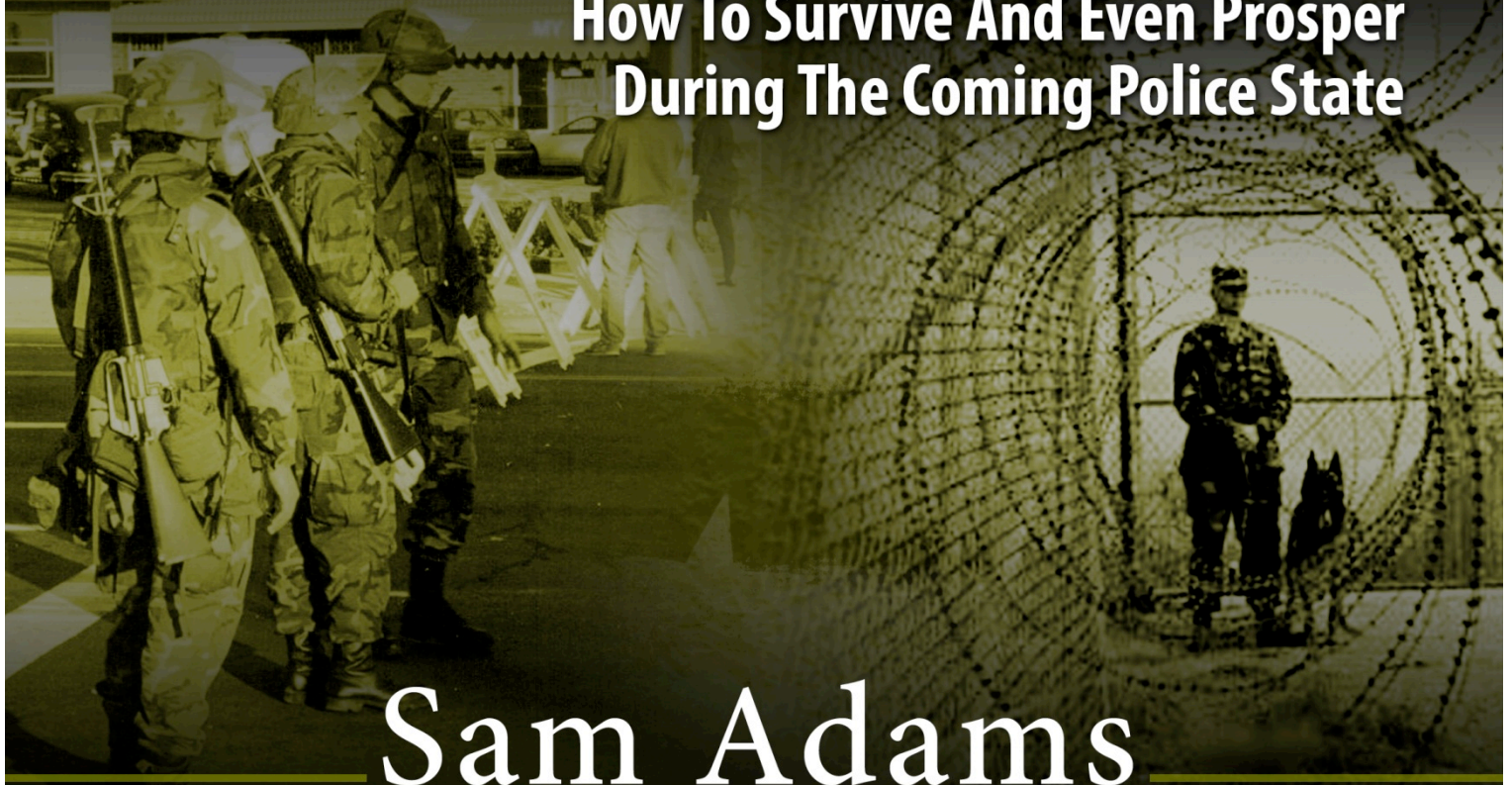

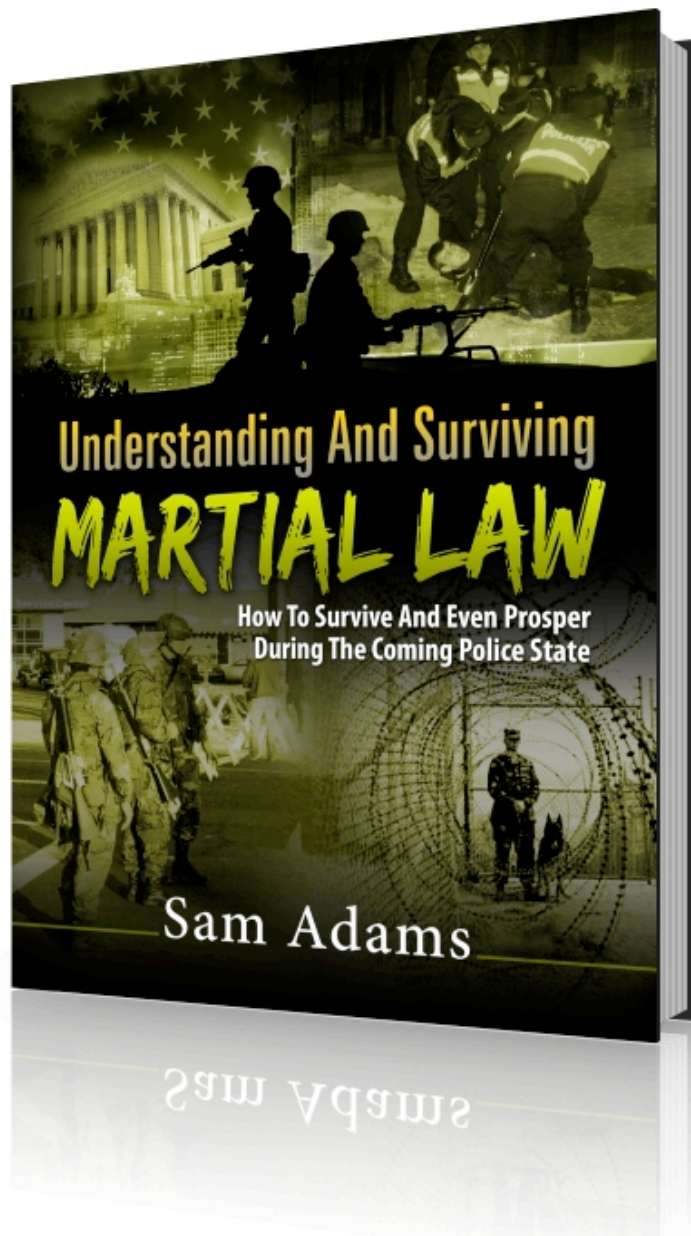

Introduction

When the term “martial law” is spoken, one gets the immediate image of jack-booted soldiers brandishing rifles, barging into the homes of average citizens and toting them off to jail or detention centers.

A picture is formed of military patrols keeping citizens in line with whatever prevailing government rules and regulations are in force at the time; of stepping in to quell simmering unrest and dissent; of ordering the daily lives of citizens – where they can congregate, what they can say or think, what they can own, *and even if they live or die.*

A government with little understanding of history or an elitist mindset towards the lessons of history, and with little or no opposition from its citizenry, can enact detrimental policies that will hasten its demise. It's a decline that will, unless reversed, result in a totalitarian form of government with no regard for the rule of law or basic human rights.



Countries that consider themselves part of western civilization like to think they are above the societal deterioration needed to bring about martial law. They think that countries based on democratic principles will not be subjected to the tight-fisted government controls that tyrannical regimes implement.

What they fail to realize is that there are really only two types of government – those that govern by the rule of law or those that govern by the whims of the people. Republics, like the United States, are ruled by law. Each person has inherent rights that exist which are considered God-given and not at the mercy of whatever political faction is in power at any given moment.

Democracies, on the other hand, are the rule of the mob. These types of government quickly deteriorate into tyrannies as groups of people try to attain power through whatever means they deem necessary. What usually arises through the ashes of these power struggles is the “benevolent” dictator, one who justifies his totalitarian take-over with the belief that only he can provide a more effective means of governing the masses.

Millions of people are killed in these coups and revolutions, all deprived of their basic rights as citizens of their respective countries. We have these examples in the Cambodian massacres, in Idi Amin, in the Soviet Union, and of course Nazi Germany.

The Founding Fathers viewed democracies as unstable and dangerous. "Democracies have been spectacles of turbulence and contention; have ever been found incompatible with personal security or the rights of property, and have in general been as short in their lives as they have been violent in their deaths," said James Madison.

Yet have we truly kept the Republic we were entrusted with? Alexander Hamilton said, "That country is free where the people have a representation in the government, so that no law can pass without their consent..." John Adams stated, "The very definition of a freeman is one who is bound by no law to which he has not consented."



But what we find is that America is increasingly becoming a country ruled by government fiat. The electorate finds themselves subjected to unconstitutional interpretations of law by a judiciary that looks not to the founding principles of our country, but to international law and foreign precedents in its rulings. Our Congress slips provisions into innocuous bills that not only infringes on our basic freedoms, but creates government entities enjoined with the task of enforcing those rulings. And all the while we sit idly by, patting ourselves on the back for our "advanced" civilization, overlooking blaring signs and portents as the country falls into ruin and mob rule around us.

We fiddle as Rome burns.

We are so distracted by our wants, so wrapped up in our petty differences and rivalries, our sense of entitlements and perceived discriminations, that we can't take the time to look over the shoulders of our legislators to see exactly what freedoms and rights the federal government is encroaching upon.

We look at enacted legislation with the attitude of "what's in it for me?" What's best for the country as a whole, or right and wrong, doesn't come into play in our critical thinking of the issues. Possible government usurpation of basic liberties and freedoms barely gives us pause. We're like two-year olds, throwing a temper tantrum in the store.

We want what we want - now.

The consequences can be damned.

After the Constitutional Convention, a woman asked Benjamin Franklin what type of government they had crafted for them. "A Republic, madam, if you can keep it," was his reply. The gift our forefathers gave us in the form of this republic, the United States of America, is in danger of being lost.

It may already be.

What are our options in this new world order? How do we survive in an era of invading totalitarianism, military intervention in civilian affairs, and enforced martial law?

How do we prepare for the day when we throw off the chains of an oppressive government and emerge as free men and women once again?

Plato, the American Founders, and Alexis de Tocqueville all understood that democracy is susceptible to a certain form of tyranny: the rule of a “benevolent” government, catering to the public’s needs and whims in exchange for their freedom. This “soft despotism” creates a servile people dependent on the largesse of government, happily abiding the tyrant’s pursuit of limitless desire as long as the tyrant’s government fulfills their own.

Chapter I

A Brief History of Tyranny

Since the beginning of time people have been involved in political maneuverings, government overthrows and takeovers, rebellions, insurrections, and power grabs. In fact, the word “tyrant” was coined in ancient Greece. Tyrannos was defined as a “sovereign or master” and did not necessarily mean a beastly dictator.

In the beginning, the Greek states were ruled by an oligarchy – the rule of a governing class of a few elite individuals – and were generally those people who were richer and more powerful.

The power struggles were many however, as successive and alternating groups tried to ascend to power. The successful groups got the support of the poor behind them, promising them oversight and justice much the way a godfather might in a Mafia-controlled area.

Unfortunately, these alliances quickly descended into democracies of mob rule. It put power directly into the hands of the people, and the laws were in constant upheaval depending on the wants and desires of the majority at any given moment. According to the Greek philosopher Plato, a democracy is one step away from tyranny, and the Greeks soon found this out.

It was in this chaos that the tyrant arose, the person that would restore law and order to the squabbling masses. Once established, they remained in power through the use of mercenary soldiers from outside their respective city states.



As the Greek culture declined and the Roman Empire became established, the word “tyrant” (tyrannus in Latin) changed in definition into the one we know today - an illegitimate ruler, someone who snatches power in a state or nation, and holds it in defiance of any constitution that might exist. This ruler exercises power through oppression and brutality against the very people he claims he wants to help.

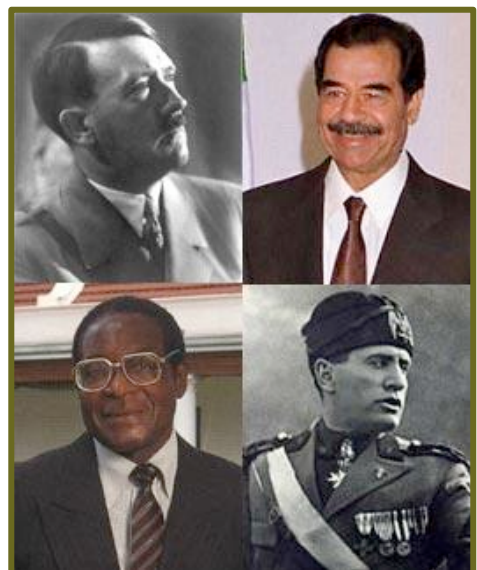


The Roman Republic was established when the last of the seven kings of Rome was deposed, around 500 B.C. The government created then had three branches – legislative, executive, and judicial - and was the foundation our Founding Fathers used when establishing the present system of government we have in the United States. In 45 B.C., Julius Caesar became the first Roman emperor, consolidating power, and being elected as dictator for life by the Roman

Senate. He moved to make his position a hereditary one, and so began the reign of the Caesars.

Tyranny followed and the decline of the Roman Empire ensued. Through excessive taxation and the destruction of the middle class; through foreign immigrants that revolted against their Roman hosts; and through an increasingly growing welfare class that demanded more and more from the government trough, Rome was decimated from within.

Closer to our time, revolutions and an endless series of coups have occurred in dozens of Third World countries, particularly during the 1970s and 1980s. Nations in Asia, Africa, Latin America and the Middle East fell to tyrants and dictators who massacred millions of their own. Even “democratic” revolutions produced new dictatorships and repressions, all through disarming the population and terrorizing them into submission.



But what does all this mean for those of us here in the United States, enjoying the privilege of living in a westernized country? Are we really any safer from such upheavals in our political system?

Consider the tactics and results of the last presidential election. Barack Obama lied during the primaries, agreeing to take public financing for the campaign. When the time came for the general election however, and after John McCain agreed to take public financing, Obama reneged on his campaign promise.



His lies allowed him to raise unrestrained amounts of money from anywhere he wished, from foreign or domestic sources. He refused public disclosure of his campaign finances, cooked his books so that many donations were recorded under \$250 (the amount that requires full disclosure), and used the group ACORN to perpetrate voter fraud.

During the election, he slipped several times about his true intentions, his socialist leanings, his religious faith, and his past associations. 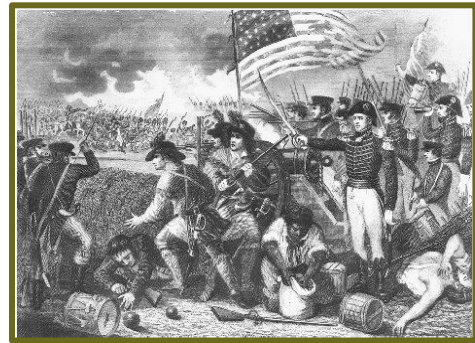

Chapter II

The History of Martial Law In the United States

According to the dictionary, martial law means to suspend civil authority and impose military authority. There have been several notable times throughout our country's history where martial law has been implemented. Some of those times were at the request of a governor; some by military decree; and others by direct authorization of the President.

General Andrew Jackson imposed martial law on a liberated New Orleans during the War of 1812 and maintained it until he received official word that the end of hostilities and the war had occurred.



On the national level, martial law has been ordered only once – by President Lincoln during the War Between the States. On a regional level, martial law has been declared once – on the Hawaiian Islands after the bombing of Pearl Harbor. The military assumed control of the government and court systems.

In 1942, the entire Pacific Coast of the United States was put under martial law measures. These measures were quickly challenged by defendants after they were put into force.

For the most part however, martial law has been declared by governors so that order and peace could be maintained during times of civil unrest.

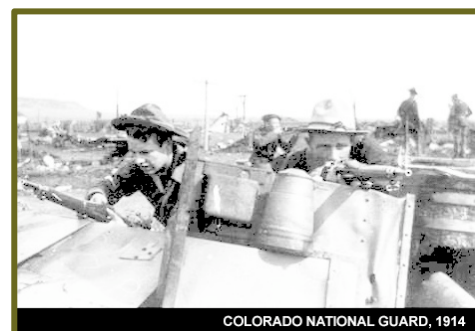
In 1899, the governor of Idaho declared martial law because of riots and the use of bombs over labor disputes with union socialists. In 1954, Phenix City, Alabama was placed under martial law after a candidate for state attorney was shot to death. In 1970, Ohio governor James Rhodes invoked limited martial law and sent in National Guard troops to quell a protest of the Vietnam War at Kent State University.



In other cases, martial law was used to enforce state agency regulations. In 1931 Governor Ross Sterling of Texas sent National Guard troops into east Texas oil fields to enforce state compliance with oil limits and the size of oil fields. The Supreme Court later invalidated Sterling's use of martial law, saying that it violated the property owners' right to due process.

Even in the absence of declared martial law however, there have been plenty of instances of military use against United States citizens. In 1807 laws were passed allowing the use of armed forces in domestic disturbances. Between 1807 and 1925, federal troops were used more than 100 times without the declaration of martial law.

In 1871, President Grant, without a formal declaration of martial law, sent troops into South Carolina to confiscate all arms and ammunition owned by the citizens of that state. In 1914, because of labor disputes, President Woodrow Wilson ordered infantry units into Colorado with orders to disarm everyone, including law enforcement and members of the state National Guard.



Between 1861 and 1862, during the early years in the War Between the States, citizens of the United States were arrested if they showed or expressed any sympathy toward the South.

Any criticism of the Lincoln administration was also grounds for arrest. In 1878, because of military abuse during Reconstruction, Congress finally set limits on the use of the military in domestic law enforcement. The Posse Comitatus Act declared it unlawful to use the military against the civilian population except as authorized by the Constitution or Congress.

That didn't stop the military in 1993 from training BATF agents before the raid of the Branch Davidians in Waco, Texas, or from giving the BATF and the FBI support during and after the stand-off. They provided Bradley fighting machines and combat engineering vehicles during the raid. The BATF and the FBI used these vehicles to tear down the compound and shoot CS agent (tear gas) projectiles into the buildings. It was two military pyrotechnic devices, fired into the compound, which ignited the fire that rapidly spread into an inferno, killing 74 men, women, and children.

And according to the Supreme Court, the president, at his discretion, has this power to suspend the Constitution, to treat insurrectionists as if they were enemies of the United States, and to decide how much force to use against a rebellion or uprising. And while the Supreme Court has said that this power is confined to the locality of actual war and when the courts are closed for administering criminal justice according to law, the presidents of the United States are infamous for seeking forgiveness after the fact instead of permission before.



They skirt the law with megalomaniacal ideas that they, as leaders of this country, are above the law. It is a messiah complex that they are the only ones that can provide a more effective means of government, that only they can save the country.

Because the legislative branch of our government, the Congress, the people we elect to represent us, has ceded its authority in one form or another to another entity, to the executive, or to the judicial branch of government since the Civil War, the president of the United States can declare himself a dictator and enforce martial law, even if the states oppose such a declaration.

How does a president accomplish this? What is a president's most effective, insidious means of putting this into place?
It's called the executive order.

Chapter III

Executive Orders

According to Article 1 of the Constitution, only Congress is allowed to make federal law. However, since the implementation of the *War and Emergency Powers Act of 1933* which placed the United States under a state of emergency and suspended the Constitution (and has never been rescinded), every president has usurped lawmaking power.

They've done this through the *executive order*.

An *executive order* is a directive issued by the president that, *whether constitutional or not*, becomes law simply by its publication in the *Federal Register*.

Until the 1950s, and the Supreme Court ruling in *Youngstown Sheet & Tube Co. vs. Sawyer*, there were no rules or regulations outlining what a president could or could not do under executive orders. And while the 1950 ruling states that executive orders are to clarify or act to further a law put forth by Congress or the Constitution and not to make law, a president simply needs to cite what laws he believes he is acting on when issuing an executive order.

While executive orders have been used by every president since George Washington, most of these were unpublished and only seen by the agencies involved. In the early 1900s, the State Department began numbering executive orders retroactively to 1862 when President Lincoln suspended *habeas corpus* in direct disregard for Article 1 Section 9 of the United States Constitution that states a person may not be imprisoned arbitrarily by the government without legal ground. He did this because of the resistance to the draft he implemented in the early stages of the War Between the States and the poor response he received from his Emancipation Proclamation that he instituted through executive order.

Executive Order 9066, under Franklin D. Roosevelt, delegated military authority to remove all people in a military zone. This paved the way for the Japanese-American internment camps on the West Coast. Americans of German and Italian descent were also sent to internment camps under executive order.

In 1999, when President Bill Clinton committed United States troops to the action in Kosovo, he did so by executive order.

Title 3—

Executive Order 13120 of April 27, 1999

The President

Ordering the Selected Reserve and Certain Individual Ready Reserve Members of the Armed Forces to Active Duty

By the authority vested in me as President by the Constitution and the laws of the United States of America, including sections 121 and 12304 of title 10, United States Code, I hereby determine that it is necessary to augment the active armed forces of the United States for the effective conduct of operations in and around the former Yugoslavia related to the conflict in Kosovo. Further, under the stated authority, I hereby authorize the Secretary of Defense, and the Secretary of Transportation with respect to the Coast Guard when it is not operating as a service in the Department of the Navy, under their respective jurisdictions, to order to active duty any units, and any individual members not assigned to a unit organized to serve as a unit, of the Selected Reserve, or any member in the Individual Ready Reserve mobilization category and designated as essential under regulations prescribed by the Secretary concerned, and to terminate the service of those units and members ordered to active duty.

This order is intended only to improve the internal management of the executive branch and is not intended to create any right or benefit, substantive or procedural, enforceable at law by a party against the United States, its agencies, its officers, or any person.

But there are executive orders on the books that have not yet been fully utilized. These orders, all which can be put into effect any time an “emergency” is declared, are in direct violation of Article 4 Section 4 of the United States Constitution which guarantees to every State in the Union a republican (representative) form of government. Martial law can be declared for anything from natural disasters like hurricanes and tornadoes, stock market crashes, riots...anything leading to civil unrest.

It was through executive orders that Hitler turned Germany into a Nazi dictatorship. Below are the executive orders that recent presidents have crafted, all with the intent of “protecting” the nation in the event of a “national emergency”. These can be implemented at a moment’s notice. Some have been revoked by newer Executive Orders that incorporate the same thing but gives the authority to another agency. They are already in the Federal Register and are, for all intents and purposes, law. The President issuing the executive order is listed in italics in parentheses at the end of each order.

Executive Order 10995: Seizure of all communications media – radio, television, newspapers, CB and Ham radio, telephones and the internet (in effect, suspension of the first amendment) (Kennedy)

Executive Order 10997: Seizure of all electrical power and fossil fuels (Kennedy)

Executive Order 10998: Seizure of all food sources, farms and farm equipment. Food will be rationed. Today some states have anti-hoarding laws on the books, stating that anything over a one week’s supply of food is considered hoarding and against the law. (Kennedy)

Executive Order 10999: Seizure of all transportation and control of all highways, interstates and seaports. Any vehicle, public or private, can be taken. (Kennedy)

Executive Order 11000: Seizure of all civilians for work under Federal supervision. (Kennedy)

Executive Order 11001: Federal takeover of all health, education, and welfare. (Kennedy)

Executive Order 11002: Authorizes the Postmaster General to register every man, woman and child in the United States. (Kennedy)

Executive Order 11003: Seizure of all airports and aircraft, public or private. (Kennedy)

Executive Order 11004: Housing and Finance given authority for population relocation. (Kennedy)

Executive Order 11005: Seizure of railroads, inland waterways, and storage facilities. (Kennedy)

Executive Order 11049: Assigns emergency preparedness functions to federal agencies. Consolidates 21 different executive orders issued over a 15-year period. (Kennedy)

Executive Order 11490: Establishes presidential control over all United States citizens, businesses, and churches in times of “emergency”. (Nixon)

Executive Order 11921: Allows the Federal Emergency Preparedness Agency to develop plans to establish control over all production and distribution, energy sources, wages, salaries, credit and the flow of money in United States financial institutions in any “national emergency”. It also states that when a state of emergency is declared by the President, Congress cannot review the action for six months. (Ford)

Executive Order 12407: Sets up ten Federal Regional Councils to govern ten Federal Regions made up of the fifty states and U.S. protectorates. Each of the states is to be divided into sub-regions so that Federal Executive control is provided over every community. (Reagan)

Executive Order 12656: Assigns emergency preparedness responsibilities. "A national emergency is any occurrence, including national disaster, military attack, technological emergency, or other emergency that seriously degrades or seriously threatens the national security of the United States. Policy for national security emergency preparedness shall be established by the President." This order includes the federal takeover of all local law enforcement agencies, wage and price controls, prohibits citizens from moving assets in or out of the United States, creates a draft, controls all means of travel, and much more. (Reagan)

Executive Order 12919: Directs various Cabinet officials to be ready to take over virtually all aspects of the United States economy during a "state of national emergency" at the direction of the President. (Clinton)

Executive Order 13010: Directs FEMA to take control over all government agencies in times of emergency. FEMA is under the direct control of the executive (presidential) branch of government.
(Clinton)

Executive Order 11051: The Director of the Office of Emergency Planning is authorized to put Executive Orders in effect in “times of increased international tension or financial crisis”. It is also to perform additional functions as the President may direct. (Kennedy)

In response to the 1933 Agricultural Adjustment Act (legislation that established price controls and taxes on farm products) Congressman James M. Beck said at the time, "I think of all the damnable heresies that have ever been suggested in connection with the Constitution, the doctrine of emergency is the worst. It means that when Congress declares an emergency, there is

no Constitution. This means its death. It is the very doctrine that the German chancellor is invoking today in the dying hours of the parliamentary body of the German republic, namely, that because of an emergency, it should grant to the German chancellor absolute power to pass any law, even though the law contradicts the Constitution of the German republic. Chancellor Hitler is at least frank about it. We pay the Constitution lip service, but the result is the same."



In addition to the power that the president has to declare an “emergency situation” on any basis and to deploy United States military against the citizenry of the United States, President George Bush entered into a treaty in 2005 with both the Canadian and Mexican governments that allows the President to use foreign troops to quell any uprising or political unrest.

Any United States president, through the Security and Prosperity Partnership Agreement treaty can call in Mexican or Canadian troops for use against United States citizens.

The Senate did not ratify this treaty. The legislators that we elected to represent us were not allowed to vote on the Security and Prosperity Partnership Agreement even though Article II: Section 2 gives the exclusive right of treaty ratification to a two-thirds majority vote by the Senate.



The reason? In 1937, the courts, in *U.S. vs. Belmont*, declared that executive agreements do not require the consensus of either branch of government in order to be enacted.

George W. Bush, on March 23, 2005, signed away all vestiges of national sovereignty and the constitutional rights of the people of the United States of America.

He signed this treaty without the authority of Congress.

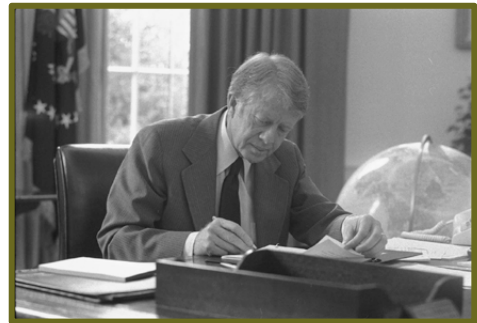
He did it through executive order.

Chapter IV

FEMA - the Shadow Government?

What is the most powerful organization in the United States? What agency was relatively unknown until a Category 5 Hurricane Andrew smashed into the United States mainland and ripped a swath that stretched from Florida to Louisiana?

The Federal Emergency Management Agency, or FEMA, was originally conceived by President Richard Nixon and established in 1979 by President Carter under Executive Order 12127. FEMA was a merger of many programs and agencies.



Those agencies included: the Federal Insurance Agency, the National Fire Prevention and Control Administration, the National Weather Service Community Preparedness Program, the Federal Preparedness Agency of the General Services Administration, and the Federal Disaster Assistance Administration activities from HUD. The Defense Department's civil defense responsibilities were also transferred to FEMA.

FEMA's powers were consolidated by President Carter to bring together several congressional acts:

- **The National Security Act of 1947** – allows for relocation of industries, services, government and other essential economic activities
- **1950 Defense Production Act** – gives the President powerful control over all economic aspects of the country
- **The Act of August 29, 1916** – gives the Secretary of the Army the authorization to seize any transportation system to move troops, materials, or anything else related to an emergency
- **The International Emergency Economic Powers Act** – allows the President to seize the property of a foreign country or national

On March 1, 2003, FEMA, along with 22 other federal agencies, programs, and offices, became part of the United States Department of Homeland Security.

FEMA's mission statement is to "reduce the loss of life and property and protect the Nation from all hazards, including natural disasters, acts of terrorism, and other man-made disasters, by leading and supporting the Nation in a risk-based, comprehensive emergency management system of preparedness, protection, response, recovery, and mitigation."

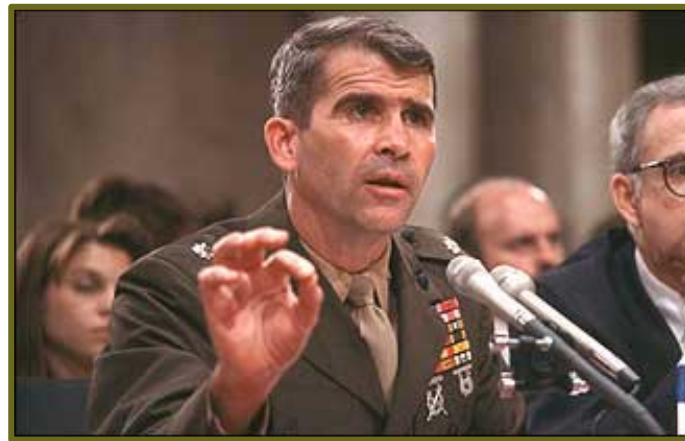
As part of the Department of Homeland Security, it also incorporates that Department's mission statement, which is to "lead the unified national effort to secure the country and preserve our freedoms. While the Department was created to secure our country against those who seek to disrupt the American way of life, our charter also includes preparation for and response to all hazards and disasters."

According to Free America and Harry V. Martin, "FEMA has developed 300 sophisticated mobile units that are capable of sustaining themselves for a month. The vehicles are located in five areas of the United States. They have tremendous communication systems and each contains a generator that would provide power to 120 homes each, but have never been used for disaster relief." So, *what are these mobile units for?*



Some people refer to FEMA as the "secret government." This organization has more power than the President of the United States or the Congress. It can suspend laws, arrest and hold prisoners without a warrant, move entire populations, seize property and food supplies, seize transportation systems and suspend the Constitution. Yet less than 20 members of Congress have the security clearance required to know exactly what FEMA's budget and mandate really entails. These few congressmen state that FEMA has a "black curtain" around its operations, and that security concerns prevent full disclosure of the agency.

During the Iran-Contra hearings in the late 1980s, Representative Jack Brooks, a Democrat from Texas questioned Oliver North directly about the National Security Council's plans – in concert with FEMA - for the continuity of government in the event of an emergency. His questions were shut down by fellow Democrat Senator Inouye of Hawaii. Here is a partial transcript of that exchange:

Sen. Inouye: *I believe that question touches on a highly sensitive and classified area so may I request that you not touch upon that, sir.*

Rep. Brooks: *I was particularly concerned, Mr. Chairman, because I had read in Miami papers and several others that there had been a plan developed by that same agency, a contingency plan in the event of an emergency, that would suspend the American constitution, and I was deeply concerned about it. I'm wondering if that was an area in which he had worked."*

Sen. Inouye: *May I most respectfully request that that matter not be touched upon at this stage. If we wish to get into this, certain arrangements can be made in executive session.*

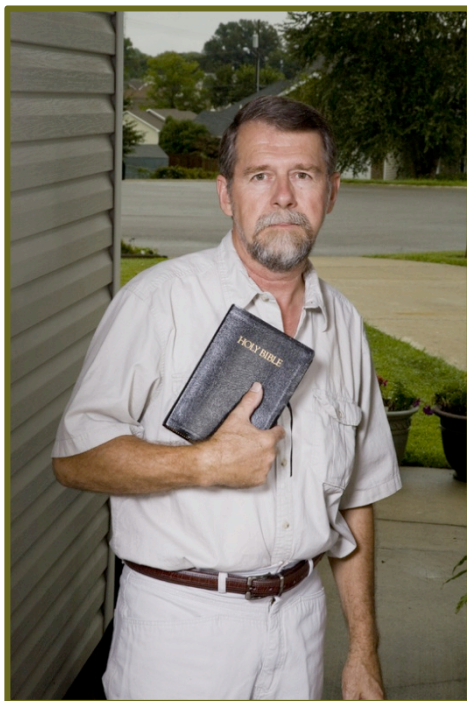
This collusion of government was not a Republican exercise or a Democrat exercise. It was a collusion of *like-minded individuals and committees, regardless of political persuasion*. That is something that must be kept in mind by the average American citizen. Party lines become increasingly blurred where power and control are concerned. The big name players on both sides of the political spectrum are usually members of the same organizations and

clubs – like the Council on Foreign Relations, the Skull and Bones Society, and the Trilateral Commission, just to name a few.

FEMA had one original purpose when first organized – insure the survival of the United States government in the event of a nuclear attack. Its power expanded to become a coordinating body during times of natural disasters such as earthquakes, hurricanes, floods and tornadoes.

However, FEMA uses only about 6 percent of its budget on disaster relief. The remainder of its budget – to the tune of billions and billions of dollars - has been used to build underground bunkers to assure the continuation of the government in case of a grand-scale national emergency – foreign or domestic.

This agency's budget and spending, in the billions and billions of dollars, is under no congressional oversight committees, and many of its programs are considered "black" or classified. In fact, according to a 2005 Los Angeles Times article, 75% of FEMA's budget is used for terrorism related activities.



In 1983, General Frank Salzedo, chief of FEMA's Civil Security Division, stated in conference that he saw FEMA's role as a "new frontier in the protection of individual and governmental leaders from assassination, and of civil and military installations from sabotage and/or attack, *as well as prevention of dissident groups from gaining access to U.S. opinion or a global audience in times of crisis.*" (bolded italics the author's)

In essence, FEMA's role was to be the new "thought police"! In that effort, FEMA has organized "Clergy Response Teams", a nationwide program to train pastors to teach their congregants to "obey the government".

It seems that the American pioneer spirit, (or "cowboy mentality" as FEMA puts it), is a problem for the government and its attempts to control the citizenry. They misuse and misquote Romans 13 about obeying government authorities as a justification for this program, and Biblically-illiterate pastors are regurgitating this swill before their congregations.

Reading Romans 13 in context with the chapters before and after it sheds a different light on this entire discourse of Paul.

Romans 13 tells us that we are to be in *subjection* to the governing authorities. This means that we are subject to the laws of man no matter what actions we take. We are not above the law in receiving punishment for any crimes or sins committed as defined by the judiciary. The state has the authority to punish, and this right is given by God.

However, the state's authority is *never* on equal footing with God. Scripture alone defines good and evil, and scripture is the authority that we, as God-fearing men and women, must obey. If the government and the scriptures come into conflict, then God is who we must be obedient to, no matter what punitive actions the state may take against us for our stand.

Citizens across the country rightly stand up for their property and second amendment rights, but as we found out in New Orleans in the Katrina aftermath, the government *will* disarm you even if you're a law-abiding citizen just trying to protect yourself from thugs.

In March 2008, Alex Jones at infowars.com did an article about FEMA spending \$22 million a year in a "terror training" program in Playas, New Mexico. It seems that the town was purchased in 2004 to begin turning it into the nation's premier counter-terrorism training facility.

Mock nuclear explosions occur, “suicide bombers” are arrested and taken down by SWAT teams, and helicopters buzz around at all hours of the night. Town residents not part of the training have gotten used to the entire thing.



FEMA’s “black” budget also includes money for Mt. Weather, a self-contained facility carved into a mountain near the town of Bluemont, West Virginia. Mt. Weather is the underground command center for FEMA, and the operational center for about one hundred Federal Relocation Centers, most of which are located in Pennsylvania, West Virginia, Virginia, Maryland, and North Carolina.

The underground bunker is a parallel government-in-waiting according to Richard Pollock in an article titled “The Mysterious Mountain” in the March 1996 edition of *The Progressive Magazine*. This mountain is part of America’s “Continuity of Government” program. Federal departments and agencies are all replicated within Mt. Weather. Mock war games are conducted yearly at the facility.

However, more than war scenarios are enacted. Domestic “crises” are also taken into consideration.



There were several times that Mt. Weather was put on actual alert status: the 1961 Cuban missile crisis, the 1963 assassination of President John F. Kennedy, the 1967 and 1968 urban riots, and during a number of anti-war demonstrations. FEMA monitors the pulse of American society constantly through satellite surveillance, intelligence reports, and state and national law enforcement agencies, to name a few.

Mt. Weather was designed to preserve our form of government during a nuclear holocaust. Executive Order 11051, signed by President Kennedy in 1962, states that “national preparedness must be achieved...as may be required to deal with increases in international tension with limited war, or with general war including attack upon the United States.”

However, Executive Order 11490, signed by President Nixon in 1969, takes executive privilege to a whole new level. His order begins “Whereas our national security is dependent upon our ability to assure continuity of government, at every level, ***in any national emergency type situation that might conceivably confront the nation...***” (bolded italics the author’s)

With subsequent executive orders detailing how the federal government is to seize control of the United States infrastructure and people in times of this nebulous “national emergency”, and with the President determining what constitutes a national emergency, an actual federal martial-law takeover of the United States, posed as a “national emergency” is just waiting for the right moment to happen.

In addition, no executive order exists that returns the country to constitutional law and rule. We’re allowing our leaders and FEMA’s quasi-shadow government to determine that time out of the goodness of their hearts.

FEMA's shadow government appears to have five identifiable branches. Their purpose is to distribute various governing functions, but not with the checks and balances like our own current constitutional republic. These branches are: the Executive, the Intelligence, the War Department, the Weapons Industry, and the Financial Department. Executive orders signed by past and current presidents put all this legislatively within FEMA's control.

Once authority is usurped by a select few, the return of constitutional law has as much chance of succeeding as the proverbial snowball's chance in hell.

In the Post-Katrina Emergency Management Reform Act of 2006, the FEMA administrator is to report directly to the Secretary of Homeland Security. This administrator serves as the principle advisor to the president on all emergency management issues.

Understand, according to this act, "catastrophic disaster" is defined as *anything* that results in "extraordinary levels of casualties or damage ***or disruption severely affecting the population (including mass evacuations), infrastructure, environment, economy, national morale...***" (bolded italics the author's)

It has been contended by Zeichner Risk Analytics, in their risk assessment of the act dated October 31, 2006, that the Internet plays a critical role in the nation's infrastructure and as such, a major Internet disruption should be considered a "catastrophic disaster."

It appears that everything is becoming an emergency, and every little event considered enough of a national emergency to suspend the Constitution.

Today, as the stock markets crash, as economic uncertainty swirls around us, as every little thing is declared an "emergency" of epic proportions by the government from a normal recession to imaginary global warming, we need to decide whether we as a country are being set up for a takeover by a select few and the imposition of martial law.

When our leaders and Congress act with impunity, enacting legislation with imagined mandates that have been in no way given by the American people, when they ignore overwhelming public opinion and outcry, when they set up as government officials tax cheats and the people directly responsible for the economic mess we're in right now, there is only one conclusion a person can come to.

We're being led like lambs to the slaughter. Our government officials will not pay the price for these decisions. We will – and our children and grandchildren. While they sit in their tax-payer funded opulence, we will be disarmed, disenfranchised, and herded like cattle to the relocation camps *already in existence*.

What will this future look like, and how can we prepare in order that we might survive it?

Chapter V

Martial Law - Coming to a Detention Center Near You?

It's a shame that we have allowed the leftist, socialist NEA teacher's union and the Department of Education to educate our children and society in the history of the United States. People and society cannot correct the mistakes of the past if they have no knowledge or an incorrect understanding of that past.

Now, some people will say that rumors of "relocation" or "internment camps" are the result of a few paranoid, delusional individuals or groups, all possessed of a conspiracy theorist mindset. They'll tell you that these rumors are nothing but fear mongering, attempting to incite panic in the general population.

However, the history of the United States is replete with examples of the forced relocation of the indigenous Indians, with camps set up during the Civil War, and with the internment of not only Japanese-Americans during World War II, but German and Italian-Americans as well.

In a little aside of the Spanish-American War, our nation embarked on a colonial expansion program at the behest of President McKinley and in response to European expansion at the time. We set our sights on the Philippine Islands, where revolutionaries had already organized into a secret society in an attempt to throw off Spanish rule and assert its own independence.

The Americans entered into an alliance with the revolutionaries, but soon after the siege of Manila it became apparent that President McKinley intended to keep the Philippines as an American protectorate.

The Filipino freedom fighters were rounded up into internment camps, faced deportation, imprisonment, or even death. An increase in the number of military garrisons around the Islands also attempted to create a climate where acceptance of American rule was expected and encouraged.

However, it was not the military, under the command of General Arthur MacArthur, Jr. (the father of famed General Douglas MacArthur) as Military Governor of the Philippines that pushed for strong-arm tactics with the Filipinos, but the Governor-General of the Philippines, William Howard Taft. Taft criticized MacArthur for his humane treatment of the prisoners, making his dislike for the Filipino people very well known.

So great was the tension between Taft and MacArthur over military action that MacArthur was eventually relieved of duty. Taft went on to become not only the 27th President of the United States but a Supreme Court Justice as well. As President and Chief Justice, he made the Federal Courts and Supreme Court much more powerful in shaping national policy.

In 1934 textile workers staged national strikes, protesting the unfair labor practices of the production mills. Several governors called out the National Guard against the striking workers, with a few declaring martial law. Georgia Governor Eugene Talmadge ordered the arrest and internment of striking workers with trial by a military tribunal. Over one hundred workers were rounded up.

After the bombing of Pearl Harbor, Japanese-Americans were deprived of their property and interred for the duration of World War II. Americans of German and Italian descent were also confined to the camps.

REX-84

In April of 1984, President Reagan signed a presidential directive that allowed FEMA to engage in secret “national readiness exercises”. This operation became known by its code name REX-84.

This exercise was to test FEMA’s ability and readiness to assume military authority in the event of a state or national emergency. This preparation was running concurrently with the launching of military operations in Central America that would later expand to the Iran-Contra affair fiasco that plagued the Reagan administration.

Deputized U.S. military and National Guard units were to be used for domestic law enforcement, conducting sweeps and taking into custody an estimated 400,000 undocumented Central American illegal aliens that then currently resided in the United States. They were to be detained at ten different centers located on military bases scattered throughout the country. Out of the REX-84 exercises came the following operations:

Operation Garden Plot: a plan the United States government has devised that is to be put into place in the event of civil disturbances. Under this plan, “civil disturbance” defines tax protestors, militia groups, religious cults, and general anti-government dissenters as “disruptive elements”. This operation calls for the use of deadly force against *any* extremist or dissident engaged in *any and all forms* of civil disorder as defined above. This operation will be used to control the population of the United States.

Operation Garden Plot allows the use of the United States military, the National Guard, and *United Nations personnel* in all operations.

Operation Cable Splicer: the program for the orderly takeover of state and local government by the federal government, of which FEMA will be the executive arm of this coming police state. Presidential executive orders have laid the legal framework for both of these operations.

The government is not as worried about foreign crises as it is internal ones. The Vietnam era war protests caused the government to change the direction of emergency powers from focusing on war times to focusing on civilian disturbance and unrest.

Several times FEMA has stood on alert, ready to put the REX-84 initiative into play. Once was at the beginning of military operations in Central America.

The second time was in 1990 with the launch of Desert Storm and the invasion of Iraq. The third time was the Los Angeles riots after the Rodney King trial. However, since the riots were contained to Los Angeles and didn't spill out to the rest of the nation, FEMA had to stand down.

Today, there are alleged to be over 800 internment camps in the United States, all ready and primed to take prisoners. These camps are serviced by railroads, roads to and from the detention centers, and many by airports. It's told that these camps are equipped to hold approximately 20,000 prisoners each. (See Appendix "A" for the locations of some of these camps.)

Years ago, a program director of the Edward R. Murrow Center had this to say in response to the dangers of FEMA and the then-prevailing concerns about the drug wars of Central America and the drug use in America. In this statement, we can substitute any "national emergency" that screams from the headlines of our daily newspapers for "drugs" and "drug use", and her statement rings as true today as it did then.

"It was James Madison's worst nightmare that a righteous faction would someday be strong enough to sweep away the Constitutional restraints designed by the framers to prevent the tyranny of centralized power, excessive privilege, and arbitrary governmental authority over the individual. These restraints, the balancing and checking of powers among the branches and layers of government, and the civil guarantees, would be the first casualties in a drug-induced national security state with Reagan's Civil Emergency Preparedness unleashed. Nevertheless, there would be those who would welcome NSC (National Security Council) into the drug fray, believing that increasing state police powers to emergency levels is the only way left to fight America's enemy within. In the short run, a national security state would probably be a relief to those whose personal security and quality of life has been diminished by drugs or drug-related crime. And, as the general public watches the progression of institutional chaos and social decay, they too may be willing to pay the ultimate price – one drug-free America for 200 years of democracy."

Chapter VI

Judicial and Administrative Tyranny

“Judicial usurpation of legislative power has become so common and so complete that the Supreme Court has become our most powerful and important instrument of government in terms of determining the nature and quality of American life.”

(Professor Lino Graglia, University of Texas School of Law, professor of constitutional law)

In 1789, when George Washington became president, there were 350 federal civilian employees to govern a nation of three million people. Today there are over three million civil service employees governing a nation of 218 million. To put that in statistical terms, there was one federal employee for every 8,500 citizens in 1789. Today there is one for every 70.

The founding fathers believed that the biggest threat to security and freedom was Big Government. The erosion of the separation of powers goes almost unchecked today because of how fast all the branches of government are expanding. That is no more evident than by the present-day rule by judicial fiat that is becoming more and more commonplace.

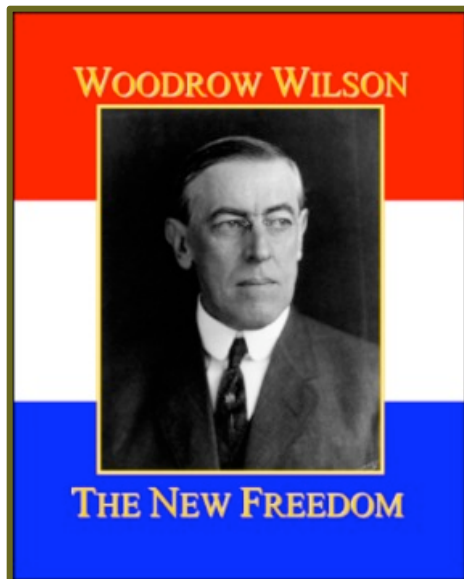
The founders incorporated several barriers or limitations on the reach of government. However, through ingenuous arguments in the courts, those that are intent on expanding the role of the federal government are enjoying victories in the court systems that today insist the Constitution is a dynamic or constantly evolving document and not a static one - one that clearly defines the limitations of government.

The general welfare clause was one such barrier. The Constitution gives the government the authority to tax and spend for the general welfare of the United States, not for one select group or individuals. The courts have ignored the “general” part of the equation, and have decreed that the states are so

interdependent that what benefits one particular group today will eventually benefit the nation as a whole in the future.

This is tripe, pure and simple. When you take from one citizen to give to another, foreign or domestic, you are stealing. There is no equalization of outcome. Americans are being forced to subsidize things with their tax dollars that in no way benefits the nation as a whole.

The commerce clause is another limitation to Big Government. The Constitution clearly states that *Congress* controls and regulates *interstate* commerce. It clearly left the regulating of *intrastate* commerce up to the individual states, as it should. But the courts have now decided that if intrastate commerce affects interstate commerce in any way, then the federal government has regulatory control over it. The courts then took it further and said that if production and manufacturing affected interstate commerce in any way, that the federal government and not the state governments were in control in that arena as well.



In the bizarre case of *Wickard vs. Filburn*, Congress sought to regulate how much grain a farmer could produce on his farm. Filburn fed his excess grain to his pigs. The courts concluded that if he had not fed his overgrowth to the pigs, he would have purchased feed, and that in turn would have affected the price of feed through interstate commerce. Therefore, the federal government could in fact regulate how much grain he was allowed to grow on his farm!

Another limitation of government was the doctrine of delegated authority. The federal government was only given certain powers by the Founding Fathers in the Constitution. They made this very clear in the Tenth Amendment that established the rights of the states and their sovereignty. However, even this quite explicit amendment is under scrutiny and judicial interpretation because of the concept of the evolution of the Constitution as a “living” document.

Woodrow Wilson defined this argument in his book *The New Freedom*. According to Wilson, the founders developed the Constitution under a Newtonian science mindset.

They constructed it according to prevailing scientific theory of the day and according to the laws of nature as they understood them to be.

However, Wilson argued, since the government is not a machine but a living thing, its construction should fall under the prevailing Darwinian science of the day and the Theory of Evolution. The government and society was seen as an organic life form. The progressives of his day eagerly looked forward to a time when the Constitution was interpreted according to Darwinian principle.

That is what we see in our present-day court systems. Instead of the rule of law being a constant that never changes, applying to everyone regardless of race, creed, gender or religion, it has instead become an evolutionary morass that destroys everything and allows only the strongest to survive. Because the law is subjected to evolutionary standards, what it means today does not necessarily insure it will mean the same thing tomorrow as society “evolves”.

This judicial usurpation of our government began in *Marbury vs. Madison* when the U.S. Supreme court claimed that the judiciary had the right and power to strike down acts of Congress that the courts deemed violated the Constitution. While judicial review is absolutely necessary in a free society, and as part of a system of checks and balances, today’s courts go further with judicial policy-making.

Court decisions have mandated tax increases, reverse discrimination, preferential treatment, and a host of other ills that the citizenry has no recourse against. Instead of our legislators making law as the Constitution provides for, and who are in their position by the will and good graces of the people, unelected judiciary now make law from the bench with the thump of a gavel.

And even if the citizens object to those rulings, and enact state laws that overturn those rulings, the courts still come in and make the voices and opinions of the citizens a moot point that cannot be overruled.

In addition to the courts, the government has grown to incorporate “administrative law”, a position fraught with even more danger. Administrative agencies – like the IRS, OSHA, Social Security, and FEMA, to name a few – are not elected positions. They are appointed, and they make and enforce rules and regulations as if they had the force of law behind them. This bypasses the legitimate role of the legislature, and again, the people become a voiceless entity.

We have allowed all of this to transpire, without question or accountability of our elected officials. Our government is so big now that it's nearly impossible to control. Laws are being written and enacted with not so much as a debate on the floor of Congress.

Like the image that is brought to mind by the old joke that asks how do you know when a politician is lying (when you see his lips moving), we can't trust the words of those who are supposed to represent us in Washington. There are a few up there who are looked at like nut cases because they constantly harangue Congress to do their duty according to Constitutional law, but they are not in the mainstream.

Instead we have soft soothing rhetoric about how Washington is going to take care of us, and how our lives are going to be better because of the white horse of government riding to our rescue. We are being manipulated by the media, coerced by our legislators, threatened by non-elected officials, and told our voices are inconsequential by black-robed judges.

How did we lose control, and when did it happen?

Chapter VII

Here are some examples of supplies that you should have on hand at all times:

- Rice
- Dried beans and peas
- Peanut Butter
- Rolled Oats
- Cans of chili, corned beef hash, sardines, salmon
- Powdered milk
- Large jars of dried herbs and spices
- Canned Nuts
- Crackers
- Paper plates
- Plastic Utensils
- Olive Oil (this is VERY important! You should take one tablespoon a day! Many nutrients need fats in order to be properly absorbed by the body. Low fat diets can actually make you sick and malnourished!)
- Dried Fruits
- Lots of soaps, cleaners, toilet paper, baby wipes, feminine hygiene products
- Any medications you feel you may need

The average person eats about 300 pounds of food in six months and needs about a gallon of water a day. Hide your food stores in places that door-to-door searches won't find because it will be confiscated. The insulation of your attic is a good place, but don't overload the sheetrock ceilings with the weight of the food. Hide food in between walls, behind scraps of junk in old buildings, or better yet, in a root cellar hidden outside.

More importantly, NEVER TELL ANYONE ABOUT YOUR FOOD STORES! Don't even tell your mother and certainly not your teenaged children. Teenagers can become angry and rebellious at a moment's notice, and in an emotional snit put your whole family in danger. Don't feed their friends – AT ALL! Many teenagers have become undisciplined little monsters, and they will blab if they think it'll be to their advantage. People will kill you for your supplies. You need to learn to start keeping your mouth shut about your business starting now!

During the transition period in martial law, before things level off, pace your eating habits so that it doesn't appear that you are living well. Don't eat too much. If you look healthy while everyone else is suffering, people will begin to get suspicious. The whole idea is to blend into the scenery, to not stand out to the government troops or your fellow citizens.

Here are a few rules to incorporate when you actually become subjected to martial law. Some of them are worth becoming habit now, before it's too late.

Rule #1: Keep your mouth shut...it's as simple as that. Don't invite people into your business and don't make yourself a target. Don't say anything that can make you a target, especially with the government. This is the first and most important habit you need to incorporate.

Rule #2: Don't trust anything the government tells you – they've been lying for a lot longer than you think. There have been very few people involved in government that are or were men and women of conscience. Most have been career politicians promoting their own personal agendas.

If you're reading this after martial law is implemented, then you know that you've been lied to and that your Constitutional rights and guarantees have been hijacked. If you're reading this beforehand, then you still have a chance to make a difference.

Rule #3: Your personal survival is more important than any dictate of government. If you need an item to survive that has been prohibited, get the item and refer back to Rule #1. Keep your mouth shut!

Caching is a legitimate method of ensuring that you have the things you need for your survival.

Rule #4: Develop a survival network. You are going to need other people and they will need you. Together you can acquire the skills and resources to survive. Be very careful of who you admit to these networks. The blowhard down the road who can't stop mouthing off may just get you all in trouble.

Rule #5: Blend in and don't draw attention to yourself. Be respectful of everyone, and MIND YOUR OWN BUSINESS. Be polite and don't look a combatant directly in the eyes. They will take this as a challenge. Walk slowly and think before you do anything. The time for cocky attitudes is over. Be humble and gentle as a lamb and don't draw attention to yourself or your family.

You must learn to live in order to survive. You and your children must learn to live to fight another day, another time. All governments fall. They all collapse. Every country becomes bloated with its own excess, and martial law and tyranny in the United States will be no exception.

Like the mythological Phoenix rising from the fires and remains of the old bird before it, if we are patient, a Republic can and will be reborn from the ashes of the country that was conceived in 1776 by our forefathers. We can only hope and pray that our children and grandchildren take better care of their legacy than we did ours.

With the sweat of their brow and the blood of their sacrifices, they will.

Chapter IX

The men that assembled in Independence Hall in Philadelphia in May of 1787 had experienced harsh tyranny under British rule and law. They had just fought a great war to be freed from that oppression. They were a tired, bedraggled lot that had sacrificed fortunes and loved ones in the attempt to become free men.

Now they were faced with a struggling nation whose Articles of Confederation were proving to be too weak and ineffective a glue to hold the states together into one cohesive nation.

The government they hoped to shape would be powerful enough to stop the disintegration of the newly formed United States of America, but itself be restricted in such a way as to prevent another tyranny and dictatorship from arising and taking hold.

The delegates came at their own expense – the Convention had no funds. Not all the states were represented all the time, with Rhode Island choosing not to participate in the Convention at all.

These men's hearts and minds were not of one accord. Some wanted a stronger central government while others, who shared a distrust of too much centralized power, were staunch state's rights supporters.

The makeup of the new government was an issue as well. Smaller states were fearful they would be abused by the larger states unless all shared an equal voice. Larger states wanted a proportional representation in this new undertaking.

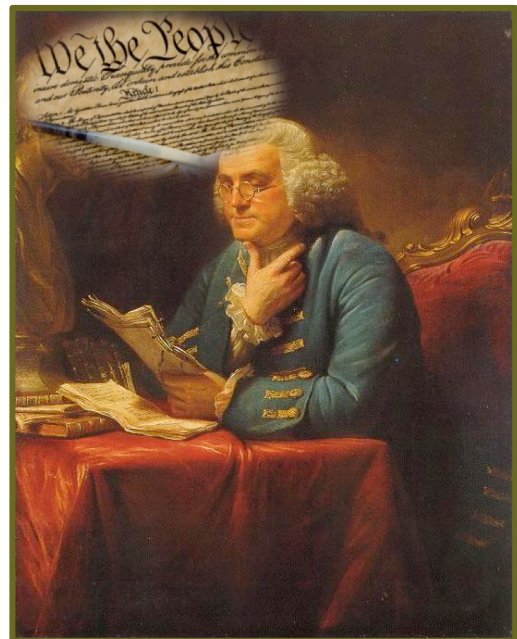
Slavery was also an issue. Some of the states wanted to abolish slavery altogether while others refused to ratify a constitution that held any anti-slavery provisions.

The Constitutional Convention had become a listless affair, with representatives unwilling to compromise and committees disinterested in keeping sight of proposed measures. George Washington, discouraged and disheartened, wrote a friend saying that he despaired of a new government ever being formed.

Then one day 81-year old Benjamin Franklin, the oldest statesman present, took the floor. His words to the squabbling men are as much a call to our hearts today as they were then.

Then, the Convention had lost its focus.

Today, we as a nation have lost our focus. We, as a people, have fragmented into squabbling factions, each unwilling to compromise or work in the interest of a greater good or a common moral frame. We are a splintered nation, and need to find our bearings once again.



Benjamin Franklin noted "...the small progress we have made after 4 or 5 weeks [was] melancholy proof of the imperfection of the human understanding."

He went on to say that what they needed was "...the Father of lights to illuminate our understandings."

He reminded the delegates of their daily prayers during the War for Independence and how God has responded to those prayers, intervening on their behalf.

He concluded with a call once again for those daily prayers. He recommended petitions before God for insight and knowledge with the following words:

“And have we forgotten that powerful friend? Or do we imagine that we no longer needed his assistance? I have lived, Sir, a long time, and the longer I live, the more convincing proofs I see of this truth – that God governs in the affairs of men. And if a sparrow cannot fall to the ground without his notice, is it probable that an empire can rise without his aid? We have been assured, Sir, in the sacred writings that ‘except the Lord build the house, they labor in vain that build it.’ I firmly believe this; and I also believe that without his concurring aid we shall succeed in the political building, no better than the builders of Babel.”

We need to become the Benjamin Franklins of our day and time, calling upon our leaders, our nation, and ourselves to turn away from the path we’re on. We need to send to Congress men and women who have within them a humbleness of spirit, a willingness to work for the good of the country, and a reliance on the God that governs the affairs of men.

Chapter X

Where Does America Go From Here?

A national poll that was performed by Synovate and conducted in January of 2006 showed a disturbing trend in the civics knowledge of the average American.

The poll, called the *McCormick Tribune Freedom Museum Poll*, found that Americans had far more knowledge about television shows like *The Simpsons* and *American Idol* than they did with the rights guaranteed by the First Amendment.

Only *one* of the 1,000 people polled could name all five of the rights given us in the First Amendment. Yet *one in five* could name all five characters in *The Simpsons* cartoon show. 21% of the respondents said the First Amendment gave us the right to raise pets, and 20% said it insured our freedom to drive.

These statistics are in sharp contrast to the Americans that Alexis de Toqueville met in his travels of America in 1830. He stated that the American of the 1830s "...will inform you what his rights are and by what means he exercises them; he will be able to point out customs which obtain in the political world. You will find that he is well acquainted with the rules of the administration, and that he is familiar with the mechanism of the laws....The American learns to know the laws by participating in the act of legislation; and he takes a lesson in the forms of government from governing."

The National Alliance for Civic Education states on its website: “Studies that compare today’s young people to old cohorts have shown that the new generation is the least knowledgeable about government structure, historical persons and events, and contemporary politics – and is the most politically disengaged.”

If the government serves at the pleasure of the people, how can our government ever be constrained to only the powers given it in the Constitution if the people are so unaware of what the Declaration of Independence and the Constitution say? If the people of the United States are so divorced from the business of government, how can we ever hope to rein it in?

John Adams said, “Our Constitution was made only for a moral and religious people. It is wholly inadequate for the government of any other.”

In the 18th century, Gouverneur Morris, a leading contributor to the drafting of the Constitution and later the U.S. minister to France, said because of the low moral character of the French people, that the American Constitution would not work in France. He said the result of France’s immoral behavior in disrespect for religion, violence, breaking of oaths and sexual immorality would lead it down the path of anarchy, revolution and chaos – which it eventually did.

Is there a lesson for us today in this?

It would seem that the first thing the United States would have to do is return to the religious heritage that founded this nation. We are going to have to stop removing all religious influences from our society. A religious people understand that God is the law-giver, and that all rights as defined in the Constitution are given by him.

In addition, there can only be a renewal of our Republic when there is respect for law and order, when our schools teach the accurate history of this nation and its foundation, and when personal responsibility is once again expected of leaders and countrymen.

Our Congress needs to resume the oversight of the powers and responsibilities that the Constitution has given it, and the Executive and Judicial branches of government need to accept their limitations as stated in the Constitution. We need to be more willing to be involved in the oversight of what laws and actions our Congress proposes and passes.

For too long, people of faith have stayed out of the political arena. As John Eidsmoe states in his book *Christianity and the Constitution*, “A society which has been conditioned to think in terms of moral and ethical relativism needs the input of those who recognize absolute principles.” The secular humanists didn’t steal our institutions – people of faith gave it to them by retreating from public life.

And as society has devolved, people of faith have become more and more insulated in their communities of like-minded friends and neighbors. We have given the school systems, the courts, the media and science over to the secular humanists and revisionists of history and wonder why our nation crumbles.

It is time for us to once again make our voices heard. We need to enter those fields that are overrun by relativistic thinking – the schools, the legal professions, the court systems, and the legislators. Christians are vital to the health and prosperity of a nation. Proverbs 14:34 tells us, “Righteousness exalteth a nation; but sin is a reproach to any people.”

Through the prophet Ezra, God has made a provisional promise to his people, the ones he has called to repentance, fasting and prayer. It is a promise that will impact a nation if we would follow through with it. ALABAMA:

Opelika - Military compound either in or very near town
Aliceville - WWII German POW camp - capacity 15,000
Ft. McClellan (Anniston) - Opposite side of town from Army Depot
Maxwell AFB (Montgomery) - Civilian prison camp established under Operation Garden Plot, currently operating with support staff and small inmate population
Talladega - Federal prison "satellite" camp

ALASKA:

Wilderness - East of Anchorage. No roads, Air & Railroad access only.
Estimated capacity of 500,000 Elmendorf AFB - Northeast area of Anchorage - far end of base. Garden Plot facility
Ft. Wainwright - Southeast of Fairbanks, the largest of these facilities, is a massive mental health facility and can hold approximately 2 million people.
Operation Garden Plot facility

ARIZONA:

Ft. Huachuca - 20 miles from Mexican border, 30 miles from Nogales. Rex '84 facility
Pinal County - on the Gila River - WWII Japanese detention camp. May be renovated.
Yuma County - Colorado River - Site of former Japanese detention camp (near proving grounds). This site was completely removed in 1990 according to some reports.
Phoenix - Federal Prison Satellite Camp. Main federal facility expanded.
Florence - WWII prison camp NOW RENOVATED, OPERATIONAL with staff & 400 prisoners, operational capacity of 3,500.
Wickenburg - Airport is ready for conversion; total capacity unknown.
Davis-Monthan AFB (Tucson) - Fully staffed and presently holding prisoners!!
Sedona - site of possible UN base

ARKANSAS:

Ft. Chaffee (near Fort Smith, Arkansas) - has new runway for aircraft, new camp facility with cap of 40,000 prisoners

Pine Bluff Arsenal - this location also is the repository for B-Z nerve agent, which causes sleepiness, dizziness, stupor; admitted use is for civilian control.

Jerome - Chicot/Drew Counties - site of WWII Japanese camps Rohwer - Descha County - site of WWII Japanese camps.

Blytheville AFB - Closed airbase now being used as camp. New wooden barracks have been constructed at this location. Classic decorations - guard towers, barbed wire, high fences.

Berryville - FEMA facility located east of Eureka Springs off Hwy. 62

Omaha - northeast of Berryville near Missouri state line, on Hwy 65 south of old wood processing plant. Possible crematory facility

CALIFORNIA:

Vandenberg AFB - Rex 84 facility, located near Lompoc & Santa Maria. Internment facility is located near the Oceanside, close to Space Launch Complex #6, also called "Slick Six". The launch site has had "a flawless failure record" and is rarely used.

Norton AFB - (closed base) now staffed with UN according to some sources

Tule Lake - area of "wildlife refuge", accessible by unpaved road, just inside Modoc County

Fort Ord - Closed in 1994, this facility is now an urban warfare training center for US and foreign troops, and may have some "P.O.W. - C.I." enclosures

Twenty-nine Palms Marine Base - Birthplace of the infamous "Would you shoot American citizens?" quiz. New camps being built on "back 40"

Oakdale - Rex 84 camp capable of holding at least 20,000 people. 90 mi. east of San Francisco

Terminal Island - (Long Beach) located next to naval shipyards operated by ChiCom shipping interests. Federal prison facility located here. Possible deportation point.

Ft. Irwin - FEMA facility near Barstow. Base is designated inactive but has staffed camp.

McClellan AFB - facility capable for 30,000 - 35,000 Sacramento - Army Depot - No specific information at this time.

Mather AFB - road to facility is blocked off by cement barriers and a stop sign.

Sign states area is restricted; as of 1997 there were barbed wire fences pointing inward, a row of stadium lights pointed toward an empty field, etc. Black boxes on poles may have been cameras.

COLORADO:

Trinidad - WWII German/Italian camp being renovated
Granada - Prowers County - WWII Japanese internment camp
Ft. Carson - along route 115 near Canon City

FLORIDA:

Avon Park - Air Force gunnery range. Avon Park has an on- base "correctional facility" which was a former WWII detention camp.
Camp Krome - DoJ detention/interrogation center, Rex 84 facility
Eglin AFB - This base is over 30 miles long, from Pensacola to Hwy 331 in De Funiak Springs. High capacity facility, presently manned and populated with some prisoners.
Pensacola - Federal Prison Camp
Everglades - It is believed that a facility may be carved out of the wilds here.

GEORGIA:

Ft. Benning - Located east of Columbus near Alabama state line.
Rex 84 site - Prisoners brought in via Lawson Army airfield.
Ft. Mc Pherson - US Force Command - Multiple reports that this will be the national headquarters and coordinating center for foreign/UN troop movement and detainee collection.
Ft. Gordon - west of Augusta - no information at this time.
Unadilla - Dooly County - Manned, staffed FEMA prison on route 230, no prisoners.
Oglethorpe - Macon County; facility is located five miles from Montezuma, three miles from Oglethorpe. This FEMA prison has no staff and no prisoners.
Morgan - Calhoun County, FEMA facility is fully manned & staffed - no prisoners.
Camilla - Mitchell County, south of Albany. This FEMA facility is located on Mt. Zion Rd approximately 5.7 miles south of Camilla. Unmanned - no prisoners, no staff.
Hawkinsville - Wilcox County; Five miles east of town, fully manned and staffed but no prisoners. Located on fire road 100/Upper River Road

Abbeville - South of Hawkinsville on US route 129; south of town off route 280 near Ocmulgee River. FEMA facility is staffed but without prisoners.

McRae - Telfair County - 1.5 miles west of McRae on Hwy 134 (8th St). Facility is on Irwinton Avenue off 8th St., manned & staffed - no prisoners.

Fort Gillem - South side of Atlanta - FEMA designated detention facility.

Fort Stewart - Savannah area - FEMA designated detention facility

HAWAII:

Halawa Heights area - Crematory facility located in hills above city. Area is marked as a state department of health laboratory.

Barbers Point NAS - There are several military areas that could be equipped for detention / deportation. Honolulu - Detention transfer facility at the Honolulu airport similar in construction to the one in Oklahoma (pentagon-shaped building where airplanes can taxi up to)

IDAHO:

Minidoka/Jerome Counties - WWII Japanese-American internment facility possibly under renovation.

Clearwater National Forest - Near Lolo Pass - Just miles from the Montana state line near Moose Creek, this unmanned facility is reported to have a nearby airfield.

Wilderness areas - Possible location. No data.

ILLINOIS:

Marseilles - located on the Illinois River off Interstate 80 on Hwy 6.

It is a relatively small facility with a cap of 1400 prisoners. Though it is small it is designed like prison facilities with barred windows, but the real smoking gun is the presence of military vehicles. Being located on the Illinois River it is possible that prisoners will be brought in by water as well as by road and air. This facility is approximately 75 miles west of Chicago with a National Guard training area nearby.

Scott AFB - Barbed wire prisoner enclosure reported to exist just off-base. More info needed, as another facility on-base is believed to exist.

Pekin - this Federal satellite prison camp is also on the Illinois River, just south of Peoria. It supplements the federal penitentiary in Marion, which is equipped to handle additional population outside on the grounds.

Chanute AFB - Rantoul, near Champaign/Urbana - this closed base had WWII - era barracks that were condemned and torn down, but the medical facility was upgraded and additional fencing put up in the area. More info needed.

Marion - federal penitentiary and satellite prison camp inside Crab Orchard Nat'l Wildlife Refuge. Manned, staffed, populated fully.

Greenfield - two federal correctional "satellite prison camps" serving Marion - populated as above

Shawnee National Forest - Pope County - this area has seen heavy traffic of foreign military equipment and troops via Illinois Central Railroad, which runs through the area. Suspected location is unknown, but may be close to Vienna and Shawnee correctional centers, located 6 mi. west of Dixon Springs

Savanna Army Depot - northwest area of state on Mississippi River

Lincoln, Sheridan, Menard, Pontiac, Galesburg - state prison facilities equipped for major expansion and close or adjacent to highways & railroad tracks. Kankakee - abandoned industrial area on west side of town (Rt.17 & Main) designated as FEMA detention site. Equipped with water tower, incinerator, a small train yard behind it and the rear of the facility is surrounded by barbed wire facing inwards.

INDIANA:

Indianapolis / Marion County - Amtrak railcar repair facility (closed); controversial site of a major alleged detention / processing center. Although some sources state that this site is a "red herring", photographic and video evidence suggests otherwise. This large facility contains large 3-4 inch gas mains to large furnaces (crematoria??), helicopter landing pads, railheads for prisoners, Red/Blue/Green zones for classifying/processing incoming personnel, one-way turnstiles, barracks, towers, high fences with razor wire, etc. Personnel with government clearance who are friendly to the patriot movement took a guided tour of the facility to confirm this site. This site is located next to a closed refrigeration plant facility.

Ft. Benjamin Harrison - located in the northeast part of Indianapolis, this base has been decommissioned from "active" use but portions are still ideally converted to hold detainees. Helicopter landing areas still exist for prisoners to be brought in by air, land & rail.

Crown Point - across street from county jail, former hospital. One wing presently being used for county work-release program, 80% of facility still unused. Possible FEMA detention center or holding facility. Camp Atterbury - facility is converted to hold prisoners and boasts two active compounds presently configured for minimum security detainees. Located just west of Interstate 65 near Edinburgh, south of Indianapolis.

Terre Haute - federal correctional institution, satellite prison camp and death facility. Equipped with crematoria reported to have a capacity of 3,000 people a day. FEMA designated facility located here.

Fort Wayne - This city located in northeast Indiana has a FEMA designated detention facility, accessible by air, road and nearby rail.

Kingsbury - this "closed" military base is adjacent to a state fish & wildlife preserve. Part of the base is converted to an industrial park, but the southern portion of this property is still used. It is bordered on the south by railroad, and is staffed with some foreign-speaking UN troops.

A local police officer who was hunting and camping close to the base in the game preserve was accosted, roughed up, and warned by the English speaking unit commander to stay away from the area. It was suggested to the officer that the welfare of his family would depend on his "silence". Located just southeast of LaPorte.

Jasper-Pulaski Wildlife Area - youth corrections farm located here. Facility is "closed", but is still staffed and being "renovated". Total capacity unknown.

Grissom AFB - this closed airbase still handles a lot of traffic, and has a "state-owned" prison compound on the southern part of the facility.

Jefferson Proving Grounds - southern Indiana - this facility was an active base with test firing occurring daily. Portions of the base have been opened to create an industrial park, but other areas are still highly restricted. A camp is believed to be located "downrange". Facility is equipped with an airfield and has a nearby rail line.

Newport - Army Depot - VX nerve gas storage facility. Secret meetings were held here in 1998 regarding the addition of the Kankakee River watershed to the Heritage Rivers Initiative.

Hammond - large enclosure identified as FEMA-designated city.

KANSAS:

Leavenworth - US Marshal's Fed Holding Facility, US Penitentiary, Federal Prison Camp, McConnell Air Force Base. Federal death penalty facility.

Concordia - WWII German POW camp used to exist at this location but there is no facility there at this time.

Ft. Riley - just north of Interstate 70, airport, near city of Manhattan.

El Dorado - federal prison converted into forced-labor camp, UNICOR industries.

Topeka - 80 acres has been converted into a temporary holding camp.

KENTUCKY:

Ashland - federal prison camp in Eastern Kentucky near the Ohio River.

Louisville - FEMA detention facility, located near restricted area US naval ordnance plant. Military airfield located at facility, which is on south side of city.

Lexington - FEMA detention facility, National Guard base with adjacent airport facility.

Manchester - federal prison camp located inside Dan Boone National Forest.

Ft. Knox - detention center, possibly located near Salt River, in restricted area of base. Local patriots advise that black Special Forces & UN gray helicopters are occasionally seen in area.

Land Between the Lakes - this area was declared a UN biosphere and is an ideal geographic location for detention facilities. Area is an isthmus extending out from Tennessee, between Lake Barkley on the east and Kentucky Lake on the west. Just scant miles from Fort Campbell in Tennessee.

LOUISIANA:

Ft. Polk - this is a main base for UN troops & personnel, and a training center for the disarmament of America.

Livingston - WWII German/Italian internment camp being renovated? Halfway between Baton Rouge and Hammond, several miles north of Interstate 12.

Oakdale - located on US route 165 about 50 miles south of Alexandria; two federal detention centers just southeast of Fort Polk.

MAINE:

Houlton - WWII German internment camp in Northern Maine, off US Route 1

MARYLAND and WASHINGTON, DC:

Ft. Meade - halfway between the District of Columbia and Baltimore. Data needed.

Detrick - Biological warfare center for the NWO, located in Frederick.

MASSACHUSETTS:

Camp Edwards / Otis AFB - Cape Cod - this "inactive" base is being converted to hold many New Englander patriots. Capacity unknown.
Ft. Devens - active detention facility. More data needed.

MICHIGAN:

Camp Grayling - Michigan National Guard base has several confirmed detention camps, classic setup with high fences, razor wire, etc. Guard towers are very well-built, sturdy. Multiple compounds within larger enclosures. Facility deep within forest area.

Sawyer AFB - Upper Peninsula - south of Marquette - No data available.

Bay City - classic enclosure with guard towers, high fence, and close to shipping port on Saginaw Bay, which connects to Lake Huron. Could be a deportation point to overseas via St. Lawrence Seaway. Southwest - possibly Berrien County - FEMA detention center.

Lansing - FEMA detention facility.

MINNESOTA:

Duluth - Federal prison camp facility. Camp Ripley - new prison facility.

MISSOURI:

Richards-Gebaur AFB - located in Grandview, near K.C.MO. A very large internment facility has been built on this base, and all base personnel are restricted from coming near it.

Ft. Leonard Wood - situated in the middle of Mark Twain National Forest in Pulaski County. This site has been known for some UN training, also home to the US Army Urban Warfare Training school "Stem Village".

Warsaw - unconfirmed report of a large concentration camp facility.

MONTANA:

Malmstrom AFB - UN aircraft groups stationed here, and possibly a detention facility.

NEBRASKA:

Scottsbluff - WWII German POW camp (renovated?). Northwest, northeast corners of state - FEMA detention facilities - more data needed.
South central part of state - many old WWII sites - some may be renovated.

NEVADA:

Elko - Ten miles south of town.

Wells - camp is located in the O'Neil basin area, 40 miles north of Wells, past Thousand Springs, west off Hwy 93 for 25 miles.

Pershing County - camp is located at I-80 mile marker 112, south side of the highway, about a mile back on the county road and then just off the road about 3/4mi.

Winnemucca - Battle Mountain area - at the base of the mountains.

Nellis Air Force Range - northwest from Las Vegas on Route 95. Nellis AFB is just north of Las Vegas on Hwy 604.

Stillwater Naval Air Station - east of Reno . No additional data.

NEW HAMPSHIRE / VERMONT:

Northern New Hampshire - near Lake Francis. No additional data.

NEW JERSEY:

Ft. Dix / McGuire AFB - possible deportation point for detainees. Lots of pictures taken of detention compounds and posted on Internet, this camp is well-known. Facility is now complete and ready for occupancy.

NEW MEXICO:

Ft. Bliss - this base actually straddles Texas state line. Just south of Alomogordo, Ft. Bliss has thousands of acres for people who refuse to go with the "New Order".

Holloman AFB (Alomogordo)- home of the German Luftwaffe in Amerika; major UN base. New facility being built on this base, according to recent visitors. Many former USAF buildings have been torn down by the busy and rapidly growing German military force located here.

Fort Stanton - currently being used as a youth detention facility approximately 35 miles north of Ruidoso, New Mexico. Not a great deal of information concerning the Lordsburg location.

White Sands Missile Range - currently being used as a storage facility for United Nations vehicles and equipment. Observers have seen this material brought in on the White Sands rail spur in Orogrande, New Mexico about thirty miles from the Texas - New Mexico Border.

NEW YORK:

Ft. Drum - two compounds: Rex 84 detention camp and FEMA detention facility. Albany - FEMA detention facility.

Otisville - federal correctional facility, near Middletown.

Buffalo - FEMA detention facility.

NORTH CAROLINA:

Camp Lejeune / New River Marine Airfield - facility has renovated, occupied WWII detention compounds and "mock city" that closely resembles Anytown, USA.

Fort Bragg - special Warfare Training Center. Renovated WWII detention facility.

Andrews - Federal experiment in putting a small town under siege. Began with the search/ hunt for survivalist Eric Rudolph. No persons were allowed in or out of town without federal permission and travel through town was highly restricted. Most residents compelled to stay in their homes. Unregistered Baptist pastor from Indiana visiting Andrews affirmed these facts.

NORTH DAKOTA:

Minot AFB - home of UN air group. More data needed on facility.

OHIO:

Camp Perry - site renovated; once used as a POW camp to house German and Italian prisoners of WWII. Some tar paper covered huts built for housing these prisoners are still standing. Recently, the construction of multiple 200-man barracks has replaced most of the huts.

Cincinnati, Cleveland, Columbus - FEMA detention facilities. Data needed.
Lima - FEMA detention facility. Another facility located in/near old stone quarry near Interstate 75. Railroad access to property, fences etc.

OKLAHOMA:

Tinker AFB (OKC) - all base personnel are prohibited from going near civilian detention area, which is under constant guard.

Will Rogers World Airport - FEMA's main processing center for west of the Mississippi. All personnel are kept out of the security zone. Federal prisoner transfer center located here (a pentagon-shaped building where airplanes can taxi up to). Photos have been taken and this site will try to post soon!

El Reno - renovated federal internment facility with CURRENT population of 12,000 on Route 66. McAlester - near Army munitions plant property - former WWII German / Italian POW camp designated for future use.

Ft. Sill (Lawton) - former WWII detention camps. More data still needed.

OREGON:

Sheridan - federal prison satellite camp northwest of Salem.

Josephine County - WWII Japanese internment camp ready for renovation.

Sheridan - FEMA detention center.

Umatilla - New prison spotted.

PENNSYLVANIA:

Allenwood - federal prison camp located south of Williamsport on the Susquehanna River. It has a current inmate population of 300, and is identified by William Pabst as having a capacity in excess of 15,000 on 400 acres.

Indiantown Gap Military Reservation - located north of Harrisburg. Used for WWII POW camp and renovated by Jimmy Carter. Was used to hold Cubans during Mariel boat lift.

Camp Hill - state prison close to Army depot. Lots of room, located in Camp Hill.

New Cumberland Army Depot - on the Susquehanna River, located off Interstate 83 and Interstate 76. Schuylkill Haven - Federal prison camp, north of Reading.

SOUTH CAROLINA:

Greenville - unoccupied youth prison camp; total capacity unknown.

Charleston - Naval Reserve & Air Force base, restricted area on naval base.

SOUTH DAKOTA:

Yankton - federal prison camp

Black Hills Nat'l Forest - north of Edgemont, southwest part of state. WWII internment camp being renovated.

TENNESSEE:

Ft. Campbell - next to Land Between the Lakes; adjacent to airfield and US Alt. 41.

Millington - federal prison camp next door to Memphis Naval Air Station.

Crossville - the site of WWII German / Italian prison camp is renovated; completed barracks and behind the camp in the woods is a training facility with high tight ropes and a rappelling deck.

Nashville - there are two buildings built on state property that are definitely built to hold prisoners. They are identical buildings - side by side on Old Briley Parkway. High barbed wire fence that curves inward.

TEXAS:

Austin - Robert Mueller Municipal airport has detention areas inside hangars.

Bastrop - prison and military vehicle motor pool.

Eden - 1500 bed privately run federal center. Currently holds illegal aliens.

Ft. Hood (Killeen) - newly built concentration camp, with towers, barbed wire etc., just like the one featured in the movie *Amerika*. Mock city for NWO shock- force training. Some footage of this area was used in *Waco: A New Revelation*

Reese AFB (Lubbock) - FEMA designated detention facility.

Sheppard AFB - in Wichita Falls just south of Ft. Sill, OK. FEMA designated detention facility.

North Dallas - near Carrollton - water treatment plant, close to interstate and railroad.

Mexia - east of Waco 33miles. WWII German facility may be renovated.

Amarillo - FEMA designated detention facility

Ft. Bliss (El Paso) - extensive renovation of buildings and from what patriots have been able to see, many of these buildings that are being renovated are being surrounded by razor wire.

Beaumont / Port Arthur area - hundreds of acres of federal camps already built on large-scale detention camp design, complete with the double rows of chain link fencing with razor type concertina wire on top of each row. Some (but not all) of these facilities are currently being used for low-risk state prisoners who require a minimum of supervision.

Ft. Worth - federal prison under construction on the site of Carswell AFB.

UTAH:

Millard County - central Utah - WWII Japanese camp. (Renovated?)

Ft. Douglas - this "inactive" military reservation has a renovated WWII concentration camp.

Migratory Bird Refuge - west of Brigham City - contains a WWII internment camp that was built before the game preserve was established.

Cedar City - east of city - no data available.

Wendover - WWII internment camp may be renovated.

Skull Valley - southwestern Camp William property - east of the old bombing range. Camp was accidentally discovered by a man and his son who were rabbit hunting; they were discovered and apprehended. Southwest of Tooele.

VIRGINIA:

Ft. A.P. Hill (Fredericksburg) - Rex 84 / FEMA facility. Estimated capacity 45,000.

Petersburg - federal satellite prison camp, south of Richmond.

WEST VIRGINIA:

Beckley - Alderson - Lewisburg - former WWII detention camps that are now converted into active federal prison complexes capable of holding several times their current populations. Alderson is presently a women's federal reformatory.

Morgantown - federal prison camp located in northern West Virginia, just north of Kingwood.

Mill Creek - FEMA detention facility.

Kingwood - newly built detention camp at Camp Dawson Army Reservation.
More data needed on Camp Dawson.

WASHINGTON:

Seattle/Tacoma - SeaTac Airport: fully operational federal transfer center

Okanogan County - borders Canada and is a site for a massive concentration camp capable of holding hundreds of thousands of people for slave labor. This is probably one of the locations that will be used to hold hard core patriots who will be held captive for the rest of their lives.

Sand Point Naval Station - Seattle - FEMA detention center used actively during the 1999 WTO protests to classify prisoners.

Ft. Lewis / McChord AFB - near Tacoma - this is one of several sites that may be used to ship prisoners overseas for slave labor.

WISCONSIN:

Ft. McCoy - Rex 84 facility with several complete interment compounds.

Oxford - central part of state - federal prison and satellite camp and FEMA detention facility.

WYOMING:

Heart Mountain - Park County north of Cody - WWII Japanese interment camp ready for renovation.

Laramie - FEMA detention facility

Southwest - near Lyman - FEMA detention facility East Yellowstone - manned internment facility - investigating patriots were apprehended by European soldiers speaking in an unknown language. Federal government assumed custody of the persons and arranged their release.

OTHER LOCATIONS IN THE UNITED STATES:

There are many other locations not listed above that are worthy of consideration as a possible detention camp site but due to space limitations and the time needed to verify, they could not be included here. Virtually all military reservations, posts, bases, stations, and depots can be considered highly suspect (because it is "federal" land).

Also fitting this category are "Regional Airports" and "International Airports" which also fall under federal jurisdiction and have limited-access areas. Mental hospitals, closed hospitals and nursing homes, closed military bases, wildlife refuges, state prisons, toxic waste dumps, hotels and other areas all have varying degrees of potential for being a detention camp area. The likelihood of a site being suspect increases with transportation access to the site, including airports/airstrips, railheads, navigable waterways & ports, interstate and US highways. Some facilities are "disguised" as industrial or commercial properties, camouflaged or even wholly contained inside large buildings (Indianapolis) or factories. Many inner-city buildings left vacant during the de-industrialization of America have been quietly acquired and held, sometimes retrofitted for their new uses.

CANADA:

Our Canadian friends tell us that virtually all Canadian military bases, especially those north of the 50th Parallel, are all set up with concentration camps. Not even half of these can be listed, but here are a few sites with the massive land space to handle any population:

Suffield CFB - just north of Medicine Hat, less than 60 miles from the USA.

Primrose Lake Air Range - 70 miles northeast of Edmonton.

Wainwright CFB - halfway between Medicine Hat and Primrose Lake.

Ft. Nelson - northernmost point on the BC Railway line.

Ft. McPherson - very cold territory ~ Northwest Territories.

Ft. Providence - located on Great Slave Lake.

Halifax - Nova Scotia. Dept. of National Defense reserve.... and others.
